Advanced Placement Philosophy

At FAHS, Advanced Placement students will be offered the opportunity to participate in a college-level learning environment. It should be understood that Advanced Placement courses are challenging. However, most students can rise to the challenge. The Advanced Placement courses require that students are independent learners practicing effective time management, directed inquiry, strong study skills, applied analysis, and critical thinking. The objectives of the courses are to excel in the Advanced Placement examination in May and to promote a successful transition to college.

Advanced Placement Background

The Advanced Placement Program is a cooperative educational endeavor between secondary schools, colleges, and universities. Since its inception in 1955, the Program has provided motivated high school students with the opportunity to take college-level courses in a high school setting. Students who participate in the program not only gain college-level skills, but in many cases they also earn college credit while they are still in high school. AP courses are taught by dedicated and enthusiastic high school teachers who follow course guidelines developed and published by the College Board." AP Exam Fees

Students taking AP courses are expected to participate in the AP exam for that course in May. The current cost of the AP exam is \$96.00 (subject to change, per the College Board), and payment will be due to Fairfield Area School District no later than December 16, 2019. The Fairfield Area School District will provide assistance with payment for students qualifying for free and reduced lunch.

If you register for an AP exam and are unable to take the exam on the exam day, you will be required to pay the \$15 exam return fee, in addition to the \$45 late exam fee, totaling \$60. Exam dates are scheduled by the College Board and must be taken on the assigned test day.

Any Fairfield Area High School student taking an Advanced Placement exam and receiving a score of a 5 can request to be reimbursed for the cost of the exam. The reimbursement form can be found on the FASD High School AP website.

AP Course Summer Assignments

Upon enrolling in an Advanced Placement class at FAHS, students will be expected to complete summer assignments, which are very important to the AP Program and serve three purposes:

- They will help acquaint students with the rigorous workload involved in an AP class.
- They will help students complete the additional amount of material contained in an AP class.
- They will help students remain sharp and mentally active over the summer. It is our philosophy that we create life-long learners and the learning does not stop in June and begin in late August.

It is the responsibility of the student to see the teacher of an AP course before the end of the school year in June to receive the assignments and materials needed for the summer assignments. Assignments will be due at specific dates throughout the summer — students must make themselves aware of the deadlines.

Failure to submit the summer assignments before or on the specified due date will result in the summer assignment grade reflecting negatively on the overall course grade when it is calculated into the course GPA. By completing the Commitment of Contract and Registration Form, you acknowledge that you are registering to complete the requested AP course, and will be enrolled in that course. Withdrawal from a registered AP course after the submission of this contract will require the approval of district administration and a college admissions office written statement that the AP course is not recommended for college entrance into requested major.

Exceptions will be made for students who move into the district over the summer months.
