They will be school property and will get passed down in subsequent years. Total cost was \$892, they are asking for ½ the amount which comes to \$446.00. Stacy Whitmore made a motion to approve the request. Joe Marcharsky seconded the motion. The vote was unanimous.• 2nd Request: Fairfield Cross Country team requesting \$250.00 help pay for prizes and medals for runners who participate in the Dipsy Doodle Dash held at Liberty Mountain on October 14th. Funds raised by the event will assist two local families in need and help fund the annual Fairfield Cross Country team summer camp. The request was denied because FAST by-laws state that donations from FAST must benefit a whole team or student body, not individual situations.
